**Admission Policy for Batch 2026-28**

**1. The Admission Committee** at ADANI INSTITUTE OF DIGITAL TECHNOLOGY MANAGEMENT – herein referred to as AIDTM – shall be responsible for conducting the admission process for Batch 2026-28 for:

- A. Post-Graduate Diploma in Management (Big Data Analytics) – herein referred to as PGDM (BDA)
- B. Post-Graduate Diploma in Management (AI & Data Science) – herein referred to as PGDM (AI & DS)

**2. PGDM Programs :**

- 2.1.** PGDM (BDA) and PGDM (AI & DS) are 2-year full-time programs offered by AIDTM, duly approved by AICTE.
- 2.2. The PGDM (BDA) program** is a rigorous and intensive course aimed at creating professionals with a strong understanding of the fundamentals of data science, which will help them in solving complex business problems. This program is perfectly suited for individuals with an analytical mindset and quantitative orientation. The program focuses on cutting-edge tools and technologies like Big Data Analytics, Machine Learning Techniques and applications, Python/ R for Future Managers, Business Analytics, Intelligence

and forecasting, Enterprise Data Visualization, Data Warehousing, Data Mining, Deep Learning, and Reinforcement Learning, social media and Social Networks Analytics, Time series and Forecasting Techniques & Analysis, and so on. The courses taught in this program will have a unique element of hands-on training and a continuous industry interface to give you a realistic feel.

The PGDM (BDA) Program is spread across six trimesters, covered over two years, to deliver the entire course curriculum.

- 2.3.** **The PGDM (AI & DS) program** aims to develop professionals with a comprehensive foundation of AI & data science to solve critical real-world problems. This program is the best fit for an individual who aspires to be a data scientist or data architect. The program focuses on Machine Learning, Deep Learning, Reinforcement Learning, Natural Language Processing (NLP), Computer Vision, Explainable AI, Gen-AI, and Integrating AI with Big Data & Cloud Technologies courses. The courses taught in this program will have a unique element of hands-on training, projects, and a continuous industry interface to give you a realistic feel. The PGDM (AI & DS) Program spans six trimesters, covering two years to deliver the entire course curriculum.
- 2.4.** Both programs also include sixteen to twenty weeks of compulsory summer internship for the program participants at the end of the first year.

### **3. Eligibility and Selection Process:**

#### **3.1. Eligibility**

3.1.1. Candidates who have written (or are yet to appear for) CAT/ XAT/ CMAT/ GMAT/ MAT/ ATMA tests are eligible to apply, as per AICTE guidelines. For CAT/ XAT/ CMAT/ MAT/ ATMA, AIDTM will accept test scores for 2025-26 and 2026-27. For GMAT, AIDTM will accept exam scores after January 1, 2026. These tests are accepted for PGDM (BDA) and PGDM (AI & DS).

3.1.2. **For PGDM (BDA),** the candidate must hold a bachelor's degree, or an equivalent qualification recognized by the Ministry of HRD, Government of India, with at least 50% marks (45% for reserved category candidates) or equivalent CGPA, of any University, incorporated by an act of the central or state legislature in India or other educational institutions established by an act of Parliament or declared to be deemed as a University under section 3 of UGC Act, 1956. Students of foreign-recognized Universities with equivalent qualifications can also apply. Students who have passed from recognized foreign universities need to submit certificates of equivalency from AIU. The bachelor's degree or equivalent qualification obtained by the candidate must entail a minimum of three years of education after completing higher secondary education (10+2) or equivalent.

3.1.3. **For PGDM (AI & DS),** the candidate must hold a bachelor's degree in BE/ B.Tech./ M. Tech in any field or Bachelor's/ Master of Science in Computer Science or B.Sc./ M.Sc. – IT/ Computer Science or B.Sc. (Hons) in Data Science/ AI/ Cyber Security/ Software Engineering or BCA/ MCA or M.Sc. in Mathematics or Statistics, or an equivalent qualification recognized by the Ministry of HRD, Government of India, with at least 50% marks (45% for reserved category candidates) or equivalent CGPA, of any University, incorporated by an act of the central or state legislature in India or other

educational institutions established by an act of Parliament or declared to be deemed as a University under section 3 of UGC Act, 1956. Students of foreign-recognized Universities with equivalent qualifications can also apply. Students who have passed from recognized foreign universities need to submit certificates of equivalency from AIU. The bachelor's degree or equivalent qualification obtained by the candidate must entail a minimum of three years of education after completing higher secondary education (10+2) or equivalent.

- 3.1.4. In case of the candidates being awarded grades / CGPA instead of marks, the equivalence would be based on the equivalence certified by the University / Institution from where they have obtained their bachelor's degree.
- 3.1.5. In case the University/ Institution does not have any scheme for converting CGPA into equivalent marks, the equivalence would be established by the AIDTM by dividing earned CGPA by the maximum possible CGPA and multiplying the quotient by 100.
- 3.1.6. A candidate who has appeared for the final year examination of a bachelor's degree or equivalent can also apply, provided:
  - a) Such a candidate must produce a certificate from the authority of the University/ Institution certifying that
    - i. The candidate has obtained 50% marks or equivalent based on the latest available grades/ marks (i.e., all the years' grades/ marks except the final year grade/ marks), and
    - ii. The candidate has completed all the requirements and has appeared for the examination/ practical, etc., for the final year/ final term, and the results are waiting for obtaining the bachelor's degree/ equivalent qualification.
  - b) Such candidates, if selected, will be allowed to join the program provisionally only if they submit such certificates at the latest on the registration date notified by AIDTM.

- c) The admission will be confirmed only if the final mark sheet/ grade sheet and degree certificate are submitted no later than the date announced by AICTE for admission 2026-28.
- d) Non-fulfilment of the above conditions within the prescribed date as above will automatically result in the cancellation of such provisional admission.

3.1.7. Candidates with Work Experience: Though prior work experience (paid and full-time employment) is not mandatory for a candidate seeking admission to the PGDM Program, candidates with relevant work experience may have an upper edge in the selection process. Please refer to Selection- Matrix in Clause 3.3.8

### **3.2. Selection Process**

- 3.2.1. The eligible candidates must apply through the Application Form, available online at <https://admissions.aidtm.ac.in/> or offline at the institute's admission office.
- 3.2.2. Based on the short-listing of applicants conducted by the admissions committee, candidates will be asked to appear for the Personal Interview (PI) round.
- 3.2.3. The selection process will be conducted online or offline, at AIDTM Campus – Gandhinagar, Gujarat.
- 3.2.4. If required, AIDTM may cancel/ add more interview time slots for the PI for shortlisted candidates. In case of cancellation of any interview time slot, the admission office will accommodate the candidates in another interview time slot. The candidates shall be notified of the same through email and/or phone calls.
- 3.2.5. The schedule for the PI will be notified along with the announcement of shortlisting. Such announcements will be made on the AIDTM website and/ or via email at a suitable time.

3.2.6. Candidates not appearing for the PI will be automatically disqualified from consideration for admission.

### **3.3. Selection Guidelines and Matrix:**

3.3.1. Candidates may submit the duly filled-in application form along with the payment of the application fee of Rs. 1500 (non-refundable). Online payment options and payment details are available in the online application form.

3.3.2. The last date for submitting the duly filled-in online application form along with the requisite application fee is July 31, 2026. Please refer to the Admission Calendar for details.

3.3.3. Applicants will bear all expenses for attending the PI.

3.3.4. Applicants are required to report online/ on campus at least 15 minutes before their scheduled slot with the PI.

3.3.5. In case an applicant is late, the Admission Representative may accommodate him/ her in the next session on the same day, only if possible.

3.3.6. If an applicant cannot appear for PI on the scheduled date due to unavoidable circumstances, he/ she or the parent/ guardian may request in writing to the Admission Committee, along with the reason for the inability to appear on the scheduled date, and seek an alternate arrangement. Such a request must be made within one week after the declaration of the PI schedule. The Admission Committee will make an appropriate decision on such a request. The decision of the Admission Committee shall be final and binding.

3.3.7. Applicants must submit the following original documents online for verification:

- a) Mark sheets, 10<sup>th</sup>, 12<sup>th</sup>, and all Graduation Semesters / Year
- b) Valid Entrance Test Score-card

- c) Experience certificate, if applicable (only paid & full-time employment)
- d) Proof of salary drawn for last 3 months, if applicable
- e) Caste certificate, if applicable (from a competent authority)
- f) Certificates of Extra-curricular achievements
- g) Identity & Address proof

3.3.8. **Selection-Matrix:** The selection of students shall be done using the following criteria, along with the weightages indicated below:

### 3.4. Merit List after Personal Interview (PI) Round:

3.4.1. The merit list will comprise two categories indicating the admissions status of the interviewed candidates:

- Offered
- Waitlist

3.4.2. All selected candidates who are offered admission should complete admission formalities within the stipulated timeline. The same will be communicated to the candidates through a Letter of Admission Offer. If a candidate fails to adhere to the deadline, the admission offer shall stand canceled seat will be offered to the waitlisted candidate.

3.4.3. Candidates on the Waitlist will be offered admission upon seats falling vacant due to non-acceptance of offers. On receiving the intimation of the admission offer, the waitlisted candidates will be required to secure admission as per the stipulated timeline.

3.4.4. If at any stage during the admission process, the information furnished by a candidate is found to be false, his/ her candidature/ admission shall be canceled, and he/ she will be barred from applying for admission to AIDTM for the next two years.

3.4.5. All communication by the institute for the admission process will be made through the website, and/ or candidates are advised to access the registered email regularly for admission updates or contact the admission office.

#### 4. Fees Structure

Notes:

- Program fee includes the cost of all study materials, books, library charges, and internet charges. It does not include hostel, mess charges, or other living expenses.
- A Caution Deposit is required to be paid along with the 1<sup>st</sup> Installment fee. It will be refunded after adjusting dues, if any, after completion of the program.

#### **4.2. Fees Payment Details**

- 4.2.1. Fee Payment for Securing Admission: The candidates who have been offered admission are required to pay a registration fee of INR 200,000 and secure their admission, as per the stipulated date.
- 4.2.2. Payment of the Remaining Program Fee: The remaining program fees will be paid in an installment mode. Candidates must pay the remaining fees in four equal installments per the payment schedule. In case of delay, a penalty may be levied as per the prescribed rules of the Institute.
- 4.2.3. Payment by demand draft may be paid by a demand draft drawn in favor of "ADANI INSTITUTE OF DIGITAL TECHNOLOGY MANAGEMENT", payable at Ahmedabad.
- 4.2.4. Online payment modes: Please refer to the Institute website [www.aidtm.ac.in](http://www.aidtm.ac.in) for details.
- 4.2.5. Cash Payment: The Institute does not accept cash payments.

#### **5. Fees Refund Policy**

- 5.1. Refunds for withdrawal of admission will be as per the provisions announced by AICTE.
- 5.2. For withdrawal of admission and seeking a refund, a candidate is required to submit the original fee receipt, admission offer letter, and the application for withdrawal, duly signed by him/her and countersigned by his/ her parent/ guardian, to the Admissions Office, AIDTM, either in person or via courier or email to [admissions@aidtm.ac.in](mailto:admissions@aidtm.ac.in)
- 5.3. If a candidate informs the Institute about his/ her withdrawal of admission in writing on or before the commencement of the program (as declared by the institute), the fees paid will be refunded after the deduction of Rs 1000 as a processing fee.
- 5.4. If a candidate withdraws from the admission after the commencement of the program, a refund will be made one month from the commencement of the 1st trimester, subject to filling up of the resultant vacant seat. If the vacant

seat is filled, the candidate will receive a refund as per clause 5.3. If the seat remains vacant due to any reason (including the non-filling of the announced number of seats for the program), no refund shall be made except a caution deposit.

**5.5.** No refund shall, in any case, be made if the candidate wishes to withdraw admission at any time during the program.

**5.6.** Cancellation of Admission: The admission of a candidate shall be cancelled at any point in time if:

- It is established that a candidate has been mistakenly admitted by AIDTM: In such an event, the fees shall be refunded by cheque within 3 weeks.
- It is found that a candidate has sought admission based on false documents and statements: In such an event, no refund shall be made, except Caution the Deposit. The candidate fails to meet the eligibility requirements as mentioned in clause 3.1.
